

TRAINING PROCESS & BEST USE GUIDANCE

To ensure the success of Market Day and the health and safety of Market Day customers, Youth Entrepreneurs (“YE”) educators should ensure that any student with a food related Market Day business has an understanding of food safety requirements and best practices. Depending upon a school’s location, those requirements could require the attainment by students of a food handlers certification. **YE now subscribes to a program that allows students and educators to obtain training and take an exam to become certified as a food handler!** The program teaches food safety and certifies that each participant that passes the exam has a basic understanding of best practices related to food. YE is making this available to all current YE educators!

YE encourages educators and any current YE students participating in Market Day with a food related business to obtain the certification. YE also wants to break down barriers for YE students, outside of food related Market Day business, who are seeking employment in the food industry or already in the food industry to obtain certification as well. YE educators may offer the course and certification to alumni based on individual facts/circumstances, however, generally speaking this course is meant for current YE students. While the certification may not be required in each state, YE highly encourages each educator to utilize this tool to ensure safe food is being served to the public. FAQ'S

What is a Food Handlers Certification?

- > A program, online or in person, that teaches a person about food safety regulations
 - Often required to work in the food service industry
- > After the course is viewed an exam must be taken to obtain the certification
 - The exam requires that a certain percentage of questions are answered correctly, or the participant fails
 - The participant can take the exam as many times as needed until they pass
- > The certification is good for 3 years

How can the students take the course and exam?

- > The course and exam are available to take on any desktop and/or mobile device

How should the educator show the course?

- > The educator should create an account for their school and then purchase 1 token for each student taking the class

How long is the course and exam?

- > All together the course and exam are approximately 75 minutes

What does it cost?

- > Each token is \$5 and is used to gain access to the course materials and the final exam. Once the exam is passed the participant obtains their Food Handlers Certification.
- > The educator is encouraged to inquire if their respective school has a similar food handlers certification program already in place and if there is no cost, to consider utilizing their in-school program.

Is a food handler certification required?

- > Some states require a Food Handlers Certification while some states don't
- > In rare circumstances, some cities/counties require specific food handler training that only their area health department offers

What should I do as an educator?

- > Research the requirements in your specific area(s)
 - Some states and counties require a food handlers' certificate, others don't. It is your responsibility as an educator to determine what is required in your area and establish which YE students would be best suited to obtain the certification based on what they are selling at Market Day. To do this you could:
 - Reach out to your local food regulatory authority or health department and find out what your requirements are
 - Leverage the knowledge of your school's food sciences teacher or department
- > Offer the course to any YE students that are handling food in conjunction with a YE event such as Market Day
- > Remove barriers by offering the course to any current YE students that are seeking employment in the food industry
- > You may also encourage students to display the food handler certificates at each booth as incentive for people to purchase food at a booth where food safety is a top priority
- > If you have students that aren't required to have the certification but want to leverage the materials, they can still go through the course but not take the exam

What if I had an account and food handler certificates through YE's previous splash page?

- > If you had students access and obtain food handler certificates, through www.efoodhandlers.com/ye the certificates are still accessible through your original login.
- > This is an historical site only so the only thing that can be done through this site is accessing and printing previously obtained food handler certificates.
